Consumer Advocate Report – Jesse Padilla

- **85th Annual State Capitol Tree Lighting Ceremony**

- **SSI News**
 - Congress is considering more cuts. A funding bill in the House of Representatives would cut Social Security's operating budget by over \$250 million in 2017. To those on SSI, the impact would be even more devastating. More people with disabilities would wait longer for a hearing on their Social Security and SSI claims.
- **Access Services**
 - The Union Station is currently under construction. The Patsaourus Transit Plaza is temporary closed. If you are traveling to Union Station on Access, the drop off zone will be at a different location. Please look at the Access or Metro website for more information.
